REGISTRATION FEE - HOW TO REGISTER, WHAT IT INCLUDES

It is time to talk about getting everyone registered for General Conference. First, the cost of registration per pastor or delegate will be **\$225 - this is the early bird rate after April 1, the rate per person will be \$250**. Please note that **this registration does not cover your hotel room or the majority of your meals (two lunches are covered with your registration: Saturday and Monday lunch.)**

The registration fee exists to help ensure that everyone who needs to attend can attend. For those who live within a day's drive or less where everyone coming from a church can fit into one or two vehicles, travel costs are relatively inexpensive. But Canada is a large country and not everyone lives within easy driving distances and air travel becomes a necessity. The registration fee helps equalize costs for everyone to travel.

Each church (society, fellowship, affiliate, church plant) **will pay the \$225 (per person before April 1)** registration fee. The following individuals are expected to attend:

Pastor — Lay delegate(s) — All additional conference-appointed ministers attending General Conference (whether ordained, commissioned, or ministerial candidate—paid or volunteer).

All participants who pay the registration fee will be reimbursed for travel expenses. Reimbursement will be based on the least expensive travel alternative (economy airfare, train, bus and/or mileage) from your location. **Mileage will be reimbursed at the rate of \$0.14 per kilometre.** Please arrange car pools where possible.

Special provisions

- Retired pastors can receive travel reimbursement **without** paying the registration fee.
- Church plants that were formed after the last General Conference do not have to pay the registration fee.

Please complete the registration form (including registration fee) before February 28, 2017, so that you can submit your travel expenses for payment.

Reimbursement for air travel can be submitted prior to Conference, but you must:

- have first sent your church's / individual registration fee to the Ministry Centre
- provide an invoice or receipt (with GST/HST amount shown)

Spouses

- Please include all the names of spouses who will be attending General Conference as they will receive a name tag and can participate in the lunch program (\$40 - Saturday and Monday lunch.)
